# V. CLERKS TO THE BOARD UPDATE:

**A. General Election Issues – Executive Order 179 –** According to the Governor's Executive Order 179, the voters are able to drop off their own ballot at their polling site having to sign the poll book when dropping off. On Election Day, Ballot processing staff are able to stay until 11:00 pm to continue the preparation of counting the ballots, and the process can resume the next morning at 9:00 am. Provisional ballots may be brought over to our office (BOE) in piece mail when completed.

**B.** Board Needs for the 2020 General – A list was given to the Board for what will be needed for the General Election. Portable Ballot Boxes will be needed for all polling locations. A motion was made to order 100 portable ballot drop boxes with #3 embroidery.

- **D. Ballot Box Update** Additional Ballot Box locations will be in Absecon, Brigantine, Egg Harbor Twp., Hamilton, Northfield, Pleasantville, Somers Point, and Ventnor. They will be scheduled to be installed by September 18.
- **E. Training Temp Staff** There is a Training Presentation being done by the BOE for all new temporary staff.
- **F. Training Poll Workers –** All Poll Workers are subject to be retrained due to all of the new election changes.
