V. PUBLIC COMMENT:

- A. Keith Davis Linwood, Republican Party Chairperson; he was concerned about a letter that was sent to all Democratic Poll Workers from the Democratic Party concerning Provisional Ballots. He felt that all Poll workers should be notified in a letter stating the correct procedure for allowing a voter to vote by Provisional Ballot according to the Attorney General.
- **B.** Mary Slomine Margate, Democratic Party Vice Chairperson; she discussed 5 items that were in the Poll Worker Manual that were cause for giving a provisional ballot to a voter. We do not want to suppress a vote and uphold the Constitution.

- C. Michael Suliman Galloway Township, Democratic Party Chairperson; he expressed his views pertaining to the Provisional Ballots. We should not suppress anyone's vote. Commissioner Couts would like it on the record that the Poll Workers work for the BOE not for the Democratic or Republican Parties.
- **D.** Randolph Lafferty Mays Landing; he feels the letter sent to the Democratic Poll Workers is contrary to the law and contrary to training. A letter should go out to all Poll Workers to disregard said letter.

Secretary Mooney said that the BOE will train according to Title 19. Our training is in compliance with Title 19.
