The Atlantic City Electric Program grant allocation for the summer program is for 61 participants, they will earn \$3000 total and work 25 hours in an 8-week program.

Mr. Kuhn discussed the adult dislocated worker service report. The number of people 352 in since July total training eligible individuals on the office, in person. Pre pandemic the number would reflect more like 200 per month was the pervious number. Re employment orientation a session every Tuesday. Mr. Kuhn concerned about the three-set process for the eligibility process with a 50% attrition rate at every step. The attrition rate did not change prior to COVID.
