Anne Phillips, resident of Brigantine, stated the Governor is still pushing for offshore wind and the Board has been silent.

Brooks Garrison, resident of Brigantine, spoke about the economic impact of offshore wind projects to Atlantic County.

Sherri Lilienfield, resident of Margate, quoted from the BOEM report that "there is no collective impact on global warming as a result of offshore wind projects."

Margaret Reale, resident of Margate, talked about the national security issues and wind turbine syndrome that relate to the offshore wind turbines.

Gina Smaniotto, resident of Cumberland County, asked how the money will be spent regarding Resolution No. 179. Administrator DelRosso, Chairwoman Kern, Commissioner Parker and Commissioner Dase responded.

John Armato, resident of Buena Vista Township, reported that most Opioid Settlement money goes to treatment instead of prevention. The money needs to be used to help more people.

Marybeth Feeney, resident of Sicklerville, stated there is nothing good from offshore wind projects.

Tom Jones, resident of Brigantine, asked if the Board has made a statement for or against the project. Construction is close to starting. Chairwoman Kern and Commissioner Dase responded.

Charlene Natale, resident of Margate, inquired if the County will provide funding for lawsuits to fight the Offshore Wind companies.

Veronica Iezzi, resident of Longport, wants to know who the citizens should go to in regard to offshore wind. Chairwoman Kern and Commissioner Balles responded.

There being no further public comments, Chairwoman Kern closed the public portion at 6:05 p.m.

Chairwoman Kern recognized Commissioner staff member, Brenda Taube at her last Board meeting.

Chairwoman Kern also attended the Field of Dreams opening day ceremony which was very heartwarming. Happy Passover to those who celebrate.
