## Minutes of Meeting July 10, 2024

CALL TO ORDER

A special meeting of the Atlantic County Board of County Commissioners was called to order by Chairwoman Maureen Kern at 4:00 p.m., Standard Time, on the above-mentioned date, via Microsoft Teams Video Conferencing.

OPEN PUBLIC MEETING STATEMENT

Adequate notice of this meeting to address a specific urgent matter was not provided, because it could not be provided in enough time due to short notice of a State LEAP Fund Grant for the Central Municipal Court of Atlantic County and the grant needs to be accepted by the County Executive on or before July 11.

Commissioner Coursey moved and Commissioner Gatto seconded a motion to authorize the emergency resolution authorizing a grant application and acceptance from the New Jersey Department of Community Affairs, Division of Local Government Services to administer LEAP grant funding to offset costs associated with adjudicating State Police summonses originating in municipalities not participating in the Central Municipal Court of Atlantic County in an amount not to exceed \$1,000,000.00.
