A regular meeting of the Atlantic County Board of County Commissioners was called to order by Chairwoman Maureen Kern at 4:00 p.m., Eastern Standard Time, on the abovementioned date, in the Stillwater Building located at 201 Shore Road, Northfield, NJ and via Microsoft Teams video conferencing.
