During this report Rhonda Lowery cited that America Works customers were referred to Stockton and Ideal therefore those customers should be added to their level of service. Torrie Garvin requested the calculation formula for accuracy.

Executive Director Report

We are at the beginning of the new fiscal year with two new youth provider's AC Boys & Girls Club as well as Atlantic County Special Services (In School) with Stockton and Ideal (Out of School). Rescare will continue with WFNJ along with Stockton. The summer youth program is up and running and will be reported on during the next meeting. Lower level population will no longer be a single class as it was not feasible to fund. Customers can be referred to the supplemental lab. A youth counselor has been hired to work with the juvenile justice system. ITA's are complete and the RFP will be in. Atlantic Cape Community College is facilitating our AC Electric Line School which will begin in September with the training being held at Tony Canale Center.

There are no provider concerns at this time however, Ren Parikh of Ideal reports that there were 28 graduates from his program and the yearbook is underway. During the month of September four youth enrolled into Atlantic Cape Community College with free tuition. We now offer a GED program to all Atlantic County residents at no cost as well as we have a construction trade program.

Diana Strelczyk reports that Stockton is looking to house all programs in one location.

Torrie Garvin reports that Rescare is focused on industry value credentials.
