- 1. Customers that test and gain employment can be tracked.
- 2. The number of referrals can differ for various reasons; enrolled is the initial and assessment is the completion a three-day assessment. The new enrollment is different with this contract period.
- 3. Eric R. added that employment verifications can be a difficult to obtain therefor the numbers can potentially be inaccurate.

Paul M. Cited that employment services in June there were 12 employer workshops; the harder to serve customers are more prevalent in the office seeking training.

Dasha B.- her agency provides transportation for customers to and from the One Stop to obtain services.

Rhonda L. Executive Director Report-

- 1. Contracts are complete
- 2. Youth Corp and Youth Works are now separate; Youth Works supervisor is Tyrone Page; going forward the TABE pre-test will be done here at the One Stop as of 7/1/18. Please refer all questions to Tyrone P.
- 3. A training on performance measures was given.

- 4. Since the Business Service Rep is retiring we are in the inquiry process to see if the OJT Rep can become the new Business Service Rep.
- 5. Monitors will visit sites more often.
- 6. There were changes made in WFNJ and the progress has been great. The participation rate should increase once Rescare is up and running.
- 7. We lost funding for the summer youth due to lack of follow through of approximately 40-50 applicants.

## Updates

ACCC will provide the Atlantic City Electric Training and classes will begin in the month of September. This is a regional project therefore we want to ensure that all involved are operating the same.

Rhonda L. will inform the training unit supervisor that VOA has tuition funds for Jole' Beauty School.

Dhara B. is recruiting/hiring for the Out of School Youth program upon eligibility; the cap is \$6000.
