Minutes




Presentation


This presentation was given by Latoyra Smith of JEVS Human Services. JEVS along with Stockton are collaboration to obtain jobs for the youth population. This collaborative endeavors to offer: Free Training/Certifications in the Hospitality Field, Job Placement, Cash Incentives, Transportation Assistance, Paid Trainings, Work Experience and Career Coaching. In partnering with Stockton Dining, Steve & Cookie's, Bally's, Harrah's, and AtlantiCare this program can be successful in servicing youth 18-24 years of age. Diana Strelczyk further presented that the On Campus Hospitality Training is a nine-week program from January to June which provides bus tickets with a level of service of 14 and is currently working on the next cohort however the challenge is that most residents does not want housekeeping as a job which deters them from registering for this program. Smith added that each participant is taken through steps to achievement to which 50% has and will receive their diploma, we will also assist with Non-License ID; upon obtaining gainful employment the participant is followed for one year.

This exercise focused on some of the barriers regarding out of school youth.

Hire AC is funding a program that will hire ex-offenders to which the Hard Rock Casino is in favor of and will greatly support this endeavor.

Lowery states that there are youth that do not want to obtain their driver's license in lieu of the continuous transportation issues therefore they will seek employment locally. A driving school should be taken in consideration; Youth Corp offers a Driver's Ed class in their program. Regina Pryor added that Uber Headquarters is located in Vineland NJ and should be contacted. Lowery further added that there is a transportation shuttle in Egg Harbor Township NJ which services to the Blackhorse Pike. A representative from this committee should attend township meetings to convey out concerns and input; the bigger issue is outreach and recruitment to engage the youth in Atlantic County. The committee Chair has volunteered to represent.

Summer Youth- funding for this 8-week program is \$300,000 servicing youth 16-24 years of age beginning June 2019 ending in August 2019 with a level of service of 100 participants @\$10.50 per hour stipend. Eligibility, Drug and Background screenings will be completed on all youth chosen to participate. We are anticipating the employer response for this program and will be in contact with the Chamber as well as Stockton for employer and recruitment updates. **Funding Freeze**- 60% funding will be frozen as of the end of February 2019. It was suggested that the performance measures should be looked at closely as well as technical support for providers.
