## WORK HISTORY AND EXPERIENCE

December 1965, enlisted in the United States Marine Corps and assigned to Parris Island, SC, Camp Lejeune NC, USS Okinawa, Camp Pendleton, CA, Republic of Vietnam and Quantico, VA. Wounded in action at Khe Sanh in the Republic of Vietnam on March 24, 1967. Honorable discharge from the United States Marine Corps on January 14, 1972.

Entered the New Jersey State Police Academy in October of 1968 and graduated on February 7, 1969. Served as general duty road Trooper at various State Police stations in Troop "C", Keyport, Laurelton, Edgewater Park, Troop "D" N.J. Turnpike, Princeton-Sub, Tactical Patrol Unit.

1974 Promoted to Crime Scene Investigator, Troop "C".

Assigned to the Executive Protection Bureau in 1976 and assigned to Governor's Office for the terms of Governor Brendan T. Byrne and Governor Thomas H. Kean. Promoted through the ranks -- Sergeant, Staff Sergeant, Sergeant First Class, Lieutenant, and Captain and Commanding Officer of Executive Protection Bureau. In that position, provided security for Governor, First Family, Attorney General, and Secretary of State. Handled security for National Governors Association in Atlantic City 1981; Republican Governors Association with former President Richard M. Nixon 1985; Security for NJ contingent at rededication of Statue of Liberty 1986; coordinated security for NJ contingent at Democratic & Republican National Conventions from 1977 to 1988.

1990 transferred to Field Operations Section, Commanding Officer, Commercial Truck Unit.

1991 transferred to Special & Technical Services Section, Commanding Officer of Crime Scene Investigations Units, Document Fraud Unit, Firearms Investigations Unit, Private Detective Unit, Equine Testing Unit, Ballistics Testing Unit.

October 1993, transferred to New Jersey State Police Academy at Sea Girt as Commandant. Responsible for training recruits in the New Jersey State Police Academy and the Municipal Police Academy, as well as in-service State Police schools. Supervised an academy staff of approximately 65 trooper-instructors, approximately 650 troopers, and recruits in training while at the Academy, and civilian staff. Trained and graduated three State Police Recruit Classes and six Municipal Police Recruit Classes.

December 23, 1995, promoted to Major, Division Staff Section which included Executive Protection Bureau, State Governmental Security Bureau, State Police Academy, Recruiting Unit, and Internal Affairs Bureau. Supervised approximately 350 troopers and civilian staff.

November 1996, transferred to Administration Section and as Major, also held the title of Chief Administrative Officer for the 4000-member New Jersey State Police. Responsibilities included budget, procurement, and all the support services and facilities of the Division of State Police. While in this post, appointed board member of the State Police Pension Board and also Board member of the State Investment Council which oversaw the 90 billion-dollar New Jersey State Pension Fund.

May 1997, promoted to Lieutenant Colonel and named Executive Officer of the New Jersey State Police, overseeing four sections with approximately 1000 troopers and civilian staff.

January 30, 1998, appointed Deputy Superintendent and, at that time, also functioned as Chief of Staff to the Superintendent of State Police.

February 28, 1999, appointed Acting Superintendent by Governor Christine Todd Whitman, overseeing the entire 4000-person staff of enlisted and civilian personnel. Also appointed to the position of State Director of Emergency Management, reporting directly to the Governor and responding to all emergency services for the State.

Mandatory retirement in November 1999 at age 55, and appointed to the New Jersey Casino Control Commission by Governor Whitman. Served as Vice Chair, and in 2001 named Acting Chair for a period of four months. Reappointed by Governor Jim McGreevey to the Casino Control Commission for a second five-year term June 2004 through June 2009.

July 6, 2009, appointed by Governor Jon Corzine to the position of Superintendent of Police/Director of Public Safety Department for the Port Authority of New York & New Jersey. In this position, responsible for the security and safety of all Port Authority Facilities -- JFK, La Guardia, Newark and Teterboro Airports, the PATH train system, George Washington Bridge, Goethals Bridge, Outer Bridge and Bayonne Bridge, Lincoln and Holland Tunnels, the Port Authority Bus Terminal, the GWB Bus Terminal, the Port Authority Shipping Ports at Newark, Bayonne, Elizabeth and Red Hook in Brooklyn. As Director of Public Safety, responsible for security and safety for the Port Authority's eight thousand employees working at various Port Authority Facilities. Coordinated security for the Port Authority for Super Bowl XLVII.

Provided security and protection for 170 Heads of State for the annual United Nation General Assembly in September/October. Responsible for security and protection for visits to the World Trade Center for Queen Elizabeth, Prince William, Pope Benedict and Pope Francis, all living former Presidents and sitting US Presidents, as well as many Heads of State of foreign governments. Retired from the Port Authority of New York & New Jersey on May 8, 2018.

As a result of the positions I have held in Law Enforcement, I possess a Top-Secret Clearance from the FBI.
